THE CLIENT ACKNOWLEDGES that Care Aware, Inc. is a referral service only and the applicants referred to the client are not employees or agents of Care Aware, Inc.
It is acknowledged and agreed that Care Aware's sole obligation to the client is to use reasonable efforts in locating and placing a quality child care provider for the request of temporary child care.
Care Aware, Inc. does not control or supervise the time, method, manner or means of accomplishing the child care task requested by the client, leaving all arrangements for mutual agreement between the child care provider and you the client.

RELEASE OF LIABILITY the client understands and acknowledges that Care Aware, Inc. is not an agent or representative of the sitter. Care Aware, Inc. is not liable in any way, nor to be held liable whatsoever, and should be held harmless for any claim of liability arising from the referral / hiring of a sitter.
You, the client, agree that it is your decision and responsibility to check references on a referred sitter. Care Aware, Inc. is not, in any way, to be held liable for any loss, damage, expense or injury, which the employer or any other person under the care of a sitter may suffer or incur because of wrongful acts, omissions, or negligence.

PLACEMENT FEE Care Aware Inc. will: 1. Refer an available and fully screened child care professional.
2. Require a Visa or MasterCard to make the reservation.
3. Charge a **non refundable** referral fee (determined by the current fee schedule) **per each placement date** a sitter's service is requested.

Our **No refund policy** will hold all cancellations for redemption within one year.
Babysitting Subscriptions available for six and twelve placements with additional savings and top priority.

SITTER'S FEE Care Aware Sitters are paid (determined to the current fee schedule) on a **Per child, Per hour basis**, directly after their services are rendered. Sitters' fee structure is consistent with all sub contractors.

PENALTIES : **Sitters are instructed not to give personal phone numbers to clients and will notify this agency concerning attempts. Sitters will be terminated from our agency if personal phone numbers are disclosed and clients can be terminated after a penalty.**
Clients will be subjected to a penalty fee (buy out fee for permanent sitter placement) of \$500.00
This will be charged to your credit card if this information is requested by anyone in your party.
